- UUNet, now a part of MCI WorldCom, was our archive host from October 1995 to December 1998
- The archives were moved to Hurricane Electric Internet Services in early 1999 when UUNet terminated anonymous ftp service. We contracted for 100 MB of storage space with HENet which has since been increased to 200 MB
